- a) Exemplifications:
 - i) We are attempting to schedule a first degree for Kory LaCroix, Daniel and Michael Zylla and Paul Coutinho. Tentative dates: July 27th, July 31st or August 1st. We have the support of Dave Novack and Mark Foresmann to move forward with this event. *Exemplification materials needed*. Discussion. The Admission Degree ceremony will be Friday, July 27, 2012, 7:00 pm at Holy Name of Jesus. Assemble by 6:30 pm. Refreshments will be served. Degree Team needs to rehearse a few days prior to the degree ceremony. All members and candidates are asked to dress in a shirt and tie.
 - ii) We discussed having a major degree toward the end of September. We have to submit this to MN Supreme soon and advertize to make it worthwhile. The proposed date of the major degree is Saturday September 29, 2012. Holy Name of Jesus facilities required: Kitchen and the Good Samaritan Center (for lunch), Gym (for assembly), Emmaus Room wing (separate rooms for 1st Degree and 2nd/3rd Degree ceremonies and degree team assembly. Separate degree chamber rooms will minimize the down time between 1st and 2nd Degree ceremonies).
 - iii) For both the first degree and the major degree events we have Father Steve's full support.

 - i) Members of our Council will participate and provide coordination with other ministries in the parish. Our council members are already involved in other ministries and bring news of activities to our council meetings. I am requesting that we use this coordination as a recruitment tool to ask men who are involved in other ministries to become knights so that we can work together to coordinate efforts and bring more coherence to HNOJ ministries. Discussion: GK to poll Brother Knights to identify those who are duly appointed Commissioners and ask them to be delegates to the Council to better coordinate K of C activities with Parish activities and initiatives. **Motion:** Make appointments to Council Service Program Committees in October, 2012 after identifying Brother Knights who are willing to be a Knights of Columbus Delegate to a Parish Commission. **Approved.**

- a) Marriage Amendment Campaign. MN Supreme is asking each council to contribute a dollar per member to the cause. **Motion** to donate one dollar per Council member to the Minnesota Catholic Conference to support its education activities in connection with the Marriage Amendment **Approved**.

- b) West Metro Ultrasound Initiative. Major fundraiser October 13, 2012 for an Ultrasound machine to be located at the St. Stevens Life Care Center in south Minneapolis. Kof C Districts 53, 54 and 58 involved. Fundraiser goal is \$26k to \$30k. Total need is \$52k. Event consists of a 4pm Mass followed by a Dinner and Speaker, Silent and Live Auction. Each participating Council is asked to contribute \$100 for start-up expenses, at least 10 Silent Auction items having a value of at least \$80 each and manpower for the event. Motion: Redirect previously dedicated Council funds from the Minnetonka Live Care Center ultrasound initiative to the West Metro Ultrasound Initiative. Donate an initial contribution of \$100 to fund the West Metro initiative. Establish a maximum donation of \$800 to the West Metro initiative. Approved.
