I asked where the Icons go after the full rotation among the councils and the 4 that were designated for Minnesota have already been assigned. Mark Foresmann is helping me with finding out if we can have one for HNOJ on a permanent basis.

- e) St. Steven's Ultra Sound Wrap Up. The following is from Deacon Luis, St. Steven's. We can still support the Clinic as we discussed last November if we choose to.
 - Event Financials
 - a. Our revenue was \$30,555.82 (Does not include \$1,563.00 of very recent donations not yet on Luke's report)
 - b. Our Expenses were \$7,756.11
 - c. That gives us a Net Income was \$22,799.71
 - Ultrasound Machine Costs
 - a. The Ultrasound will cost \$26,450.
 - b. Supreme will contribute ½ the cost of the machine at \$13,225 leaving \$13,225 to come from our Net Income to pay for the machine
 - c. This leaves us \$9,574.71 to apply to essential additional expenses needed to operate the machine once we have it.
 - Essential Additional Needs for Operating the Machine
 - a. Remodeling of the Ultrasound Room \$3,500
 - b. NIFLA Training and Membership \$4,830
 - c. Nurse Workstation and IP Phone \$1,100
 - d. Total of \$9,430.00 which is almost exactly what's left

- e) Holy Name Kitchen. The current convection oven is aging and cooks unevenly. A used convection oven is available at auction. Steve Zylla has discussed the matter with Parish Administrator Finger who is undecided about whether to accept a donated replacement of the current oven. Questions to be answered: 1) Does the current oven operate in a satisfactory manner? 2) Does Parish Administration agree there is a need to replace the current oven? 3) If Council 13096 acquires the used oven and donates it to the Parish, will the donated oven be accepted and placed in service?

Subject to a satisfactory inspection of the prospective replacement unit by Steve Zylla and Eugene Dust, **a Motion** to approve up to \$500 to purchase a used convection oven to be donated to Holy Name Parish is **Approved** on condition that 1) the Parish will accept the used convection oven as a suitable replacement for the current convection oven, 2) the replacement unit can be purchased for an amount not to exceed \$500, and 3) the total cost shall include installation fittings.
