 - (1) The status of the responses and Liturgical plans will be discussed and finalized at the District 53 meeting on May 1, 2014
 - (2) Deacon Hanson will offer a Eucharistic Communion and Prayer service if the District is unable to secure a Priest to celebrate Mass.
 - ii) The Holy Name Knights of Columbus Ladies Auxiliary will hold their Officer installation concurrently with the District Council Officer installation.

 - iv) Three dinner bids for 100 participants were evaluated, discussed and voted upon.

 - (a) Red's Catering: (Option 1) Roast Pork, Mashed Potatoes & Gravy, Mixed Vegetables, Cole Slaw, Rolls, Coffee and Milk. \$1,489.16, includes gratuity. 8 votes. Red's was selected. Ask for a deduction for Coffee and Milk. DGK Swing to contact all bidders to thank and notify them of their bid status so they can release the date for other business opportunities.
 - (b) Countryside Café: Rigatoni, Citrus Chicken, Seasonal Vegetables, Penne w/Alfredo Sauce, Garden or Caesar Salad w/breadsticks, Assorted Brownies and Pumpkin Bars. \$1,435 (Estimated \$1,693 including gratuity). 2 votes.

- (c) KFC Catering: Original Chicken, Mashed Potatoes & Gravy, Cole Slaw, Baked Beans, Biscuits. \$952.80 (no gratuity). 1 vote.
- (2) Beverages: Beer (4 cases, 2 regular and 2 light), Wine (6 magnums or equivalent sized boxes, 3 red, 3 white), Water and Lemonade (lemonade mix left over from Seafood Buffet). **Beverage Budget \$120 Approved.**
