#### Per DD Tom Mechels:

At this meeting each council will receive the Success Planner, Leaders Guide Book, placemats, buttons and the new state pin. Several things to think about and plan for prior to the meeting:

At our Midsummer District meeting I attended last weekend, the State Officers and District Deputies voted to participate in the Wheelchair Program. The State Officers are asking for \$300 (price of two chairs) from each District. At this time, they will place an order for one container. Small container = 100-110 wheelchairs, Large Container = 280 wheelchairs. (Numbers depend on size of chairs) It will take 3-4 months for delivery and the chairs will be distributed within the state.
