# RE: District Deputy Report April 2020

And then let's not forget the power of prayer! Fr. Lon Konold, from Christ the King Retreat Center in Buffalo, shared some wonderful thoughts on **prayer and the various types and ways to enter into authentic prayer** during his talk at St George in Long Lake (March 5<sup>th</sup>). #### 1. Cancellations due to the Covid-19 Pandemic

- State Convention at Breezy Point instead the convention will be held "digitally".
- State Free Throw Contest State awards will be issued to top Regional winners.
- Ladies Auxiliary 50<sup>th</sup> Convention that was scheduled for April 25<sup>th</sup>.
- Tootsie Rolls tootsie roll order have been stopped. Program Chair Dan Irvin will be checking with councils before releasing shipments. Councils may opt to run their drives during the summer or fall depending on developments.
- District 1<sup>st</sup> Degrees councils are encouraged to conduct the new Exemplification of Charity, Unity and Fraternity
- 4<sup>th</sup> Degree Spring Exemplification that was scheduled for April 18<sup>th</sup>

#### 2. Continuity of Council Operations

Here's a recap of recent information/recommendations:

**Council Meetings:** It is recommended that councils hold digital meetings using one of the many tools presented during the March 26<sup>th</sup> Webinar (see item 7, Webinars). The Medina Council is testing a couple methods The Council intends to conduct their April 14<sup>th</sup> meeting digitally. (At this point, Zoom appears to be their preferred tool.) I may be able to assist your council also - feel free to give me a call.

**Fraternal Year 2020-2021 Elections** – voting may take place via email. The March 26<sup>th</sup> webinar also included information on the use of Google Forms, Survey Monkey, and Doodle for this purpose.

**New Exemplification of Charity, Unity and Fraternity** - Ceremonial Director, Don Trudeau encourages councils to use the video in conducting the Exemplification of Charity, Unity and Fraternity while keeping attendees to a minimum, i.e. under ten, in compliance with Covid-19 guidelines. At a minimum, he sees exemplifications being conducted in homes with two officers, the candidate(s) and guest(s). The video should be paused as appropriate similar to the 1<sup>st</sup> degree DVD ceremony.

As reported previously, I have the cable and fibers for each council. Contact me if you plan to conduct an exemplification and I'll mail or deliver if possible.

**State Convention** - will be held "digitally". Details are forthcoming. Delegates should register for the convention by <u>CLICKING HERE</u>. Room reservations at Breezy Point have been cancelled. Payments are being refunded. <u>Do not call the Resort</u>.

**Council Business** – In addition to remote meetings, our State Deputy advises that we utilize electronic tools to perform other council functions such as approving and paying bills, elections, candidate admissions, and attending to charitable activities. *"The grand knight should approve the expense, send to the FS to enter into member management for payment, the treasurer should write the check and send to the grand knight for his second signature and mail off." – All (with the exception of the check signature) electronically.* 

#### 3. Award Application Deadlines

The deadline for State award applications has been extended from April 1<sup>st</sup> to April 15<sup>th</sup>. To assess the State's Overall Programs Entry form, <u>Click Here</u>. Again – entries on this application can be transferred to the SP7 (the Columbian Award) in June. Be "creative" but not too creative in filling it out.

The deadline for the Columbian SP7 application remains June 30<sup>th</sup>.
